### Full Council Meeting, 17th November 2025 Minutes

Chairman; Councillor Webster

Councillors present: Allan, Brooks, Halford, Hesketh, Keyes, Lee-Bromley,

Pearson and Webster.

Also present: Town Clerk, Edwina Parry, County Councillor James Tomlinson, Wyre Councillor Dulcie Atkins, and 8 members of the public.

#### 120(2025-26) Apologies for absence

Councillors Atkinson and Perkins.

PCSO Creighton.

#### 121(2025-26) Declaration of Interests and Dispensations

There were no Declarations of Interest declared or requests for dispensations.

#### 122(2025-26) Public participation

The meeting was adjourned to allow members of the public to speak. Councillor Brooks arrived.

A summary is provided below.

#### County Councillor (CC) James Tomlinson reported:

- i. He expressed thanks to the Garstang Community Sports Club and Booths for allowing business customers to park in their car parks during the High Street works. Councillor Hesketh thanked him for visiting every individual business affected by the High Street works.
- ii. A member of the public raised concerns about an ongoing faulty streetlamp column at the junction of Hawthorne Avenue and Croston Road.

#### Wyre Councillor Dulcie Atkins reported:

- The black bollards recently installed along the High Street by the kerb build out, should be green. The kerb build out should be completed by Wednesday 19/11/2025.
- ii) She is investigating car-parking permit options with Wyre Council.
- iii) The official opening of the skateboard park will take place at 11:00am on 18 November 2025. She has also proposed installing CCTV on the YMCA building to provide coverage of the skateboard park. The Mayor thanked her for her efforts in delivering the new facility.
- iv) The Mayor also reported an uprooted tree on the Riverside following the recent storm.

Members of the public spoke about item 10.

- i) The loss of a parking bay was not a major issue. A resident of the High Street raised concerns regarding the white "keep clear" markings and bar markings across driveways and Weinds to maintain access. He asked whether these markings could be incorporated into the proposed waiting restrictions so they could be properly enforced. County Councillor Tomlinson confirmed that, during his recent walkabout, the access at No. 13 was being repeatedly blocked.
- ii) There is confusion over the current signage on the High Street. The signs are unclear, leading to confusion among motorists. A request was made for clearer, improved signage.
- iii) Concerns were raised about how issues relating to the High Street works had developed into a "blame game" between different authorities and groups, particularly on social media. The member of the public felt that this did not reflect well on the parties concerned.
- iv) A representative from the Chamber of Trade stated that, in light of recent events, there may be an opportunity to reinvigorate the group.

The meeting was reconvened.

#### 123(2025-26) **Announcements**

The Mayor congratulated the dual hatted Chairman of Garstang in Bloom, Councillor Pearson for all his recent achievements with the Garstang Bloomers. She also thanked the Lengthsman for all his hard work at Kepple Lane Park which had resulted in the Town Council being presented with a Silver Gilt Award in the 'Small Park' category.

#### 124(2025-26) Minutes of the last meeting

A copy of the minutes of the meeting held on 20 October 2025 had been circulated.

**Resolved:** The minutes of the Town Council meeting held on 20 October 2025 were confirmed and signed as a true record.

The Council approved to bring item 12 forward.

## 125(2025-26) <u>High Street, Garstang, Wyre, Revocation and Vs Parking Restrictions</u> (00894.21407)

The Council noted that the County Council is considering the above proposal. In summary the waiting restriction (i.e. no parking) is being extended to include the removal of one parking bay outside the old Conway cards.

**Resolved:** The Town Council responded as follows.

- i) Accepted the loss of 1 parking bay, as detailed on the proposed restrictions.
- ii) That the white "keep clear" markings and bar markings across access driveways and Weinds be covered by an enforceable 'No waiting' restriction.
- iii) That the County Council should make significant improvements to the signage along the High Street making it clear that you can only park in the marked parking bays.

The Town Council **further resolved** that the Clerk would seek clarification of the correct road names from Lancashire County Council, noting discrepancies between Mario, Google, and other mapping platforms.

#### 126(2025-26) Finance payments, Clerk/RFO

Councillors were asked to approve the payments, detailed vouchers 137 – 146, in the Appendix. Vouchers 134 & 135 were paid in between October and November meetings (audit trail below).

**Resolved:** Councillors approved the payment voucher numbers 137 – 146, as detailed in the Appendix. Councillors also approved the retrospective suspension of Financial Regulations in relation to voucher 135, permitting the contractor to purchase materials in advance of completing the works.

#### 127(2025-26) Wyre Council Planning, Clerk

The Council noted that no Planning Application consultations had been received. The Council noted that they had been consulted on a Planning appeal for 74 Lancaster Road Garstang.

**Resolved:** That the Clerk reports to Wyre Council, that the minute from the Planning Committee meeting containing a typo stating 23/04/2024 be corrected to 23/04/2025.

## 129(2025-26) Wyre Planning Policy - Draft Conservation Area Appraisals and Management Plans Consultation, Clerk

The Town Council acknowledged the Wyre Planning Policy - Draft Conservation Area Appraisals and Management Plans Consultation, noting that comments were requested by 8 December 2025.

**Resolved:** That the response be delegated to the Clerk, in consultation with Councillors Keyes and Perkins. The response will state that the Council supports an Article 4 Directive specifically for the conservation area and strongly objects to the proposed removal of the High Street car park, which should remain within the plan.

## 130(2025-26) Congratulations to Garstang in Bloom – Britain in Bloom Awards and North West in Bloom Awards, Councillor Webster

**Resolved:** That Garstang Town Council formally congratulates Garstang in Bloom, including Alan and Liz Pearson and the entire Bloom team, for achieving Gold in the Britain in Bloom Awards, being named Best Small Town in the UK and winning Gold in the North West in Bloom Awards. The Town Council acknowledges their dedication, hard work and outstanding contribution to the community.

#### 131(2025-26) Greater Garstang Partnership Board, Councillor Pearson

Reference documents: The minutes of the meeting held on 16/09/2025 and the agenda for the session on 11/11/2025 had been circulated. The next meeting is to be held on 13/01/2026.

Councillor Pearson reported that it had been a challenging period, but progress was being made.

- i) Market Hall: A contractor had been appointed, and a letter of intent issued.
- ii) The GGPB were collaborating with Garstang Heritage to upgrade and repair signs and plaques.
- iii) A wicker sculpture was being considered for the mound.
- iv) A new commemoration sign for Fairtrade's 25th anniversary was under consideration.
- v) To date, £200,000 had been invested in Garstang.

The Mayor suggested that this information could be shared with the public via a press release from Wyre Council. She also noted that the GGPB website had not been updated since 2024 and suggested that a Wyre officer could assist in bringing it up to date.

**Resolved:** That the next Amenities Committee meeting be rescheduled to 7.00pm, Monday 8/12/2025. This will enable the meeting to be extended from 40 minutes to 60 minutes and avoid any overlap with Full Council.

## f) Wyre Planning Policy - Planning Policy Newsletter November 2025 Housing Monitoring Report 2025

The council has produced a <u>Housing Monitoring Report (HMR) 2025</u>. This HMR has a base date of 1 April 2025, it takes account of all available information up to and including 31 March 2025. The council's HMR demonstrates a deliverable housing land supply position of **9.78 years**.

#### **Employment Land Monitoring Report 2024-2025**

The Council has now published its <u>Employment Monitoring Report</u> which covers the period 1 April 2024 to 31 March 2025.

There is 32.04ha of employment land that is available on allocated sites. Of this available land 16.21ha is committed through the granting of planning permissions.

The take up for the whole of Wyre, including on non-allocated sites for 2024/25 is 0.56ha.

#### **Affordable Housing Position Statement 2025**

In response to an increased interest in affordable housing being promoted as exception sites we have produced an <u>Affordable Housing Position Statement</u> which sets out the council's affordable housing supply as of the base date as of 1st April 2025, across the borough by sub-area. The affordable housing need is informed by the Housing Needs Assessment 2024. The position statement sets out the supply of all affordable housing, which will assist developers and the Affordable Housing Delivery Officer in understanding the need of tenures in the future.

The Council is currently carrying out a public consultation on Draft Conservation Area Appraisals and Management Plan Documents. The consultation period has been extended and will now run until **5.00pm Monday 15 December 2025**.
